Concerning the substances listed in the Annex XVII, we point out the possible presence in some NBR coloured compound (different from black) of the substance DINP CAS n° 28553-12-0, whose application is forbidden in toys and childcare articles. The eventual presence is highlighted in the compound IMDS and in point n° 15 of the MSDS.

Furthermore, we confirm that compounds are according GADSL (Global Automotive Declarable Substance List) 2015 version 1.1.

We confirm also that all our compounds do not contain any 201 substances listed in the list of REACH SVHC and following updating of 16/07/2019, except for VMQ compounds, in which there could be the presence of the substances D4 (cas 556-67-2), D5 (cas 541-02-6), D6 (cas 540-97-6).

If any restricted substance is present that fact is stated in section 15 of the safety data sheet in accordance with the Regulation.

This information is supplied in good faith and are considered careful to the publication data of current letter, following test of current composition and of information received from suppliers. In any case, if there will be some changes, transmitted from our suppliers, we will inform you immediately.

For NBR and EPDM compound (sulphur or peroxide vulcanisation) it is possible to find negligible trails of lead and cadmium in form of their oxide, as impurities of used zinc oxide (however below the tolerance limit indicated in the Regulation).

It is not excluded the presence of IPA (PAH / PAK) existing in the carbon black and some aromatic plasticizers, but against declarations of their producers, always within the admissible limit (except for the restriction concerning the extended or frequent contact with human skin or oral cavities).
